Please apply sunscreen prior to dropping off your child. Sunscreen will be re-applied throughout the day. Sunscreen must be supplied and labeled with child's name. A permission slip is required in order to apply sunscreen.

All lunches must be "brown bag/picnic" style. Nothing that requires refrigeration or heating.
